Subject: Intimation regarding NIL Re-lodgement requests of physical share transfers under SEBI Circular no. SEBI/HO/MIRSD/MIRSD-PoD/P/CIR/2025/97 dated 2nd July, 2025

Pursuant to SEBI Circular No. SEBI/HO/MIRSD/MIRSD-PoD/P/CIR/2025/97 dated 02nd July, 2025 (“SEBI Circular”), the Securities and Exchange Board of India (“SEBI”) introduced a special window to facilitate Re-lodgement of transfer requests pertaining to physical shares which were originally lodged prior to 01st April, 2019 and were rejected, returned or not attended due to deficiencies in documents, process or otherwise.
